A \$10 jury fee is required for all applicants. All fees are non-refundable.

Vendors must supply their own equipment including canopies, tables, chairs, canopy weights, etc. Vendors are responsible for leaving the area in the same condition they found it. Please remove all items, trash, food containers, etc. Please note this event is outdoors - outdoor conditions and ground should be expected. Vendors are responsible for collecting sales tax, obtaining proper permits and having current insurance.

At this time, we can only accommodate space for 2 food trucks with their own quiet generators. Please reach out BEFORE applying. Due to the location of the festival we are limited in space. Given that the market is located on the Clinton Village Green, consideration is given to restaurants who are Chamber members and support the community year round.
